**Notification of Distribution Sources
 Pursuant to Rule 19a-1 under the Investment Company Act of 1940**

As noted in the table below, Highland Global Allocation Fund (the “Fund”), a series of Highland Funds II, is making a distribution payable on March 23, 2018, a portion of which is estimated to be in excess of the Fund’s current and accumulated undistributed net income. As of March 23, 2018, the estimated sources of this distribution were as follows:

The ultimate composition of this distribution may vary from the estimates provided above due to a variety of factors including future income and expenses, and realized gains and losses from the purchase and sale of securities.
