Notification of Distribution Sources
Pursuant to Rule 19a-1 under the Investment Company Act of 1940

As noted in the table below, Highland Floating Rate Opportunities Fund (the “Fund”) is making a distribution payable on March 31, 2019, a portion of which is estimated to be in excess of the Fund’s current and accumulated undistributed net income.
